5 NSC Planning and Regulatory Committee

It was noted there were no items of direct relevance to Wrington which had been discussed at the meeting held 13 April. However a proposed housing development at Wrington Lane/Cobthorn Way in Congresbury had been approved.

Councillors agreed there was no comment to make on this application.

Application 16/P/0775/F - Bristol Airport, North Side Road, Felton, BS48 3DP

The Council agreed there was no comment to make on this application. However, if NSC approved the application, Councillors would expect the removal of the building and corridor, as well as in reinstatement of the site, to be conditioned.

8 Other Planning Issues

North Somerset Council - Site Allocations Plan (Consultation Draft)

It was agreed Cllr Glynn would prepare a response to this consultation, with the deadline for comments, 28 April 2016.

It was noted that a hard copy was not available of the comment submitted on the Department for Communities and Local Government's consultation on the implementation of planning changes, as the response had been submitted online via 'SurveyMonkey', with no alternative mechanism provided.

Finally, it was reported that a residents group had been set up in response to a letter sent by GL Hearn Ltd, planning consultants, to local residents and submission of 16/P/0691/EIA1 for a proposed housing development on land at Cox's Green, Wrington. This residents group is to be called the Wrington Village Alliance.
