# Minutes of a Meeting of the Planning Committee of Wrington Parish Council held in the John Locke Room on Thursday 13 September 2016

#### 1 Apologies for absence

Apologies were received from Cllrs Simpson and Ledbury.

#### 2 Declarations of Interest

Cllr Yamanaka declared a personal interest in relation to 16/P/1990/F (All Saints Church, Station Road, Wrington, BS40 5LF) as she is a member of the church choir.

#### 3 Public Participation

There were no members of the public present.

#### 4 Minutes of the previous meeting

The Minutes of the meeting held 23 August were reviewed and adopted as a true record. There were no matters arising.

#### 5 NSC Planning and Regulatory Committee

It was reported that the only items of direct relevance to Wrington on the agenda for the meeting to be held on 14 September were 16/P/1455/F & 16/P/1486/F (both for Bristol Airport, North Side Road, Felton, BS48 3DY). Furthermore it was understood the proposed housing development at Wrington Lane/Cobthorn Way in Congresbury would be the subject of an Inquiry provisionally scheduled for March or April of next year.

#### 7 Planning Applications

A list of planning applications had been circulated prior to the meeting.

Application 16/P/1945/WT - Four Aces, Blackmoor, Langford, BS40 5HJ It was noted the site is not in the parish but is adjacent to the boundary. The Council agreed to object to the application because, as the height of the trees had not been specified, it was impossible to judge whether the proposed work was excessive.

# Application 16/P/1948/CUPA - Barn at Rydings Farm, Silver Street, Wrington, BS40 5QN

It was agreed there was no objection in principle to the proposed development. However, Councillors wanted to raise the following:-

- The site is outside the settlement boundary, in an elevated position and is highly visible in the Green Belt. Given this location, the proposal could be improved if the windows were of a more traditional design. The material to be used to make the windows has not been specified and the Council would prefer the use of hardwood.
- As the proposed development is in the centre of the farm an agricultural tie should be conditioned.
- The Bat Survey is out of date and a new survey should be undertaken.

Application 16/P/1968/F - Warfords, School Road, Wrington, BS40 5NB The Council agreed there were no objections to this application.

## Application 16/P/1978/WT - Wringbrook House, Station Road, Wrington, BS40 5LG

It was agreed there were no objections to this application.

### Application 16/P/1990/F - All Saints Church, Station Road, Wrington, BS40 5LF

Councillors agreed there was no objection in principle to the proposed work. However, as there is anecdotal evidence that bats use the building a Bat Survey should be undertaken.
