# 1 Apologies for absence

## 8 Other Planning Issues

 Alleged airport parking at Hortswood Industrial Estate (enforcement case 2017/0359)

The resident outlined the nuisance caused by airport parking at the site. The escalation in the expansion of the operation was also commented on. Recent correspondence from NSC saying that no evidence of airport parking could be found was read out. It was agreed to support residents by contacting the Enforcement Case Officer.
