## 1 Apologies for absence

#### 5 NSC Planning and Regulatory Committee

#### 7 Planning Applications

A list of planning applications had been circulated prior to the meeting.

**24/P/0668/FUL - The Barn, Lye Hole Farm, Sutton Lane, Redhill, BS40 5RL** Councillors discussed the history of applications relating to the site. In 2016 NSC had approved a change of use from residential to holiday let accommodation. Therefore, it was agreed there was no objection to the

proposed reversal of change of use from holiday accommodation back to residential.

## 24/P/0694/FUL - Stepstones Farm, Half Yard, Langford, BS40 5HS

After discussing the application, it was agreed there was no objection in principle to the proposed change of use. However, if approved, conditions should be imposed limiting hours of use, noise levels and traffic movements/timing.

[Post meeting note – it was subsequently agreed via email that exterior lighting should also be conditioned, suggesting that movement-activated exterior lighting is used and only when hours of darkness coincide with hours of operation.]

## 8 Other Planning Issues

Cllr Yamanaka mentioned that she was working on the Rural Strategy consultation but would email Councillors about this shortly.
