You are summoned to attend a meeting of Wrington Parish Council to be held on **Wednesday 16 October 2024**. The meeting will commence at 7.30pm and consider the items set out below.

All Council meetings are open to the press and members of the public unless otherwise agreed. The public will only be able to speak under 'public participation', agenda item 4. The public are allowed to observe the whole meeting if they so wish.

1. To receive apologies for non-attendance and to approve the reasons where appropriate.
2. To receive declarations of Disclosable Pecuniary Interests (DPI) related to agenda items and to receive any amendments to the Register of interests.

 - c. Email from a resident concerning the possibility of installing double yellow lines alongside the church wall/hedge in Redhill to prevent parking on a blind corner.
